Security Engineering - Course Outline NWEN 405: 2013 Trimester 1

This document sets out the workload and assessment requirements for NWEN 405. It also provides contact information for staff involved in the course. If the contents of this document are altered during the course, you will be advised of the change by an announcement in lectures and/or on the <u>course web site</u>. A printed copy of this document is held in the School Office.

The Course

The Internet's role as a large, public, distributed system has raised security to an issue of critical importance. This course examines security mechanisms, security policies, security evaluation and risk management, security issues in networks and operating systems and software security.

Learning Objectives

By the end of the course, students should be able to:

- 1. Demonstrate their understanding of key security terminology through activities such as writing as reports related to practical work (BE graduate attributes 2(b)) and 3(f)).
- 2. Demonstrate their understanding of key security engineering principles by applying those principles to the analysis of a secure system (BE graduate attributes <u>2(b)</u>), <u>3(a)</u>, <u>3(c)</u>, <u>3(d)</u>) and <u>3(f)</u>).
- 3. Demonstrate their understanding of threats to computer systems by being able to carry out the assessment of the security of a networked system (BE graduate attributes 2(b)), 3(a), 3(c), 3(d)) and 3(f)).

Course content

The course will include the following topics:

- 1. Security usability/psychology.
- 2. Security protocols and their evaluation.
- 3. Security policies.
- 4. Access control.
- 5. Network security.

Course Delivery

There will be two weekly one hour lectures and two practical projects. Students will be expected to have read the appropriate readings before the class so that they can ask appropriate questions and contribute. There will also be a test halfway through the course to help with preparation for the examination.

Trimester dates

Group work

The first project is best done in a group of up to 4 people.

Readings

The textbook for NWEN 405 is: Security Engineering: A Guide to Building Dependable Distributed Systems. Ross Anderson. Second Edition. Ross Anderson has made his book available online.

Materials and equipment

No special materials or equipment are required for this course.

Field trip

There will be a security workshop that runs three days during the mid trimester break.

Assessment requirements

There are two practical projects, a practical workshop, a terms test and a final examination for this course. The first project will give you practice at the design, implementation and security evaluation of a secure system and the examination will test your knowledge of key concepts and the second project will allow you to assess the security of a networked system.

All work should be submitted through the School's online submission system.

Your grade for NWEN 405 will be determined based on the following assessment weightings:

The <u>timetable for final examinations</u> will be available from the University web site and will be posted on a notice board outside the faculty office.

The terms test will be up to three hours long. The final examination will be three hours long. No computers, electronic calculators or similar device will be allowed in the final examination. Paper non-English to English dictionaries will be permitted. You are permitted to bring on **one single-sided** A4 page of **hand written** notes to the examination.

Penalties

It is expected that all internally assessed work will be handed in on the due date. However, with permission from the course organiser, it may be possible to negotiate a few days grace.

Mandatory Requirements

You must gain at least a **D** in the final examination. Should you have problems with submission of the internally assessed work, **contact the course organiser** as soon as possible.

Passing NWEN 405

To pass NWEN 405, a student must satisfy mandatory requirements and gain at least a C grade overall.

Plagiarism

Working Together and Plagiarism

We encourage you to discuss the principles of the course and assessed work with other students, to help and seek help with programming details, problems involving the lab machines. However, any work you hand in must be your own work.

The <u>School policy on Plagiarism</u> (claiming other people's work as your own) is available from the course home page. Please read it. We will penalise anyone we find plagiarising, whether from students currently doing the course, or from other sources. Students who knowingly allow other students to copy their work may also be penalised. If you have had help from someone else (other than a tutor), it is always safe to state the help that you got. For example, if you had help from someone else in writing a component of your code, it is not plagiarism as long as you state (eg, as a comment in the code) who helped you in writing the method.

Use of Turnitin

Student work provided for assessment in this course may be checked for academic integrity by the electronic search engine http://www.turnitin.com. Turnitin is an online plagiarism prevention tool which identifies material that may have been copied from other sources including the Internet, books, journals, periodicals or the work of other students. Turnitin is used to assist academic staff in detecting misreferencing, misquotation, and the inclusion of unattributed material, which may be forms of cheating or plagiarism. At the discretion of the head of School, handwritten work may be copy typed by the School and subject to checking by turnitin. You are strongly advised to check with your tutor or the course coordinator if you are uncertain about how to use and cite material from other sources. Turnitin will retain a copy of submitted materials on behalf of the University for detection of future plagiarism, but access to the full text of submissions will not be made available to any other party.

Retention of Submitted Work

For the purposes of accreditation of the BE, some of your work may be copied for review by the accreditation panel.
