The <u>Oceania RDA Committee (ORDAC)</u> is excited to see the <u>National Library implementing</u> <u>official RDA!</u> We will be cheering them on and watching with interest how it goes over the next few months.

In ORDAC membership news, we have been joined by a couple of new ACORD representatives (ACORD is the CatSIG equivalent in Australia), replacing one of the founding ORDAC members who has stepped aside to work on an Official RDA scoping project in Australia.

New LIANZA CatSIG representative(s) on ORDAC needed!

On that note, we need a new CatSIG representative on ORDAC (or two new representatives, since we also can have up to three). This could be you! If you use RDA in your institution and you are interested in how it can be developed to meet your community's needs, then do consider joining me on ORDAC as a CatSIG rep. This is an opportunity to contribute your perspective (the more perspectives the better!), and it is an excellent professional development opportunity. I personally have found that I am a lot more confident in my understanding of the standard, which makes it easier to make decisions about how to adapt to changes being made by other institutions, and processing the implications of adopting new RDA elements.

Oceania RDA Committee (ORDAC) update

RDA Steering Committee meetings & documents

As the CatSIG representative on ORDAC, I have been supporting Charlotte Christiansen in her role as Oceania representative to the RDA Steering Committee (RSC) in preparing for meetings by reading and providing feedback on discussion papers and proposals.

Since the last issue of Catapult, the RSC has met twice, in April and July. The ORDAC proposal on Dual-naming of Corporate Body and Place was discussed at both meetings, and progress is being made. Examples from Oceania and Europe have been submitted to support the options being proposed. I will report back on progress in the next issue. Thank you to those who submitted feedback on this proposal!

Other papers being discussed by the RSC include a paper from the Religions Working about any of the public agendation of the Toolkit, and making the language referencing religions more neutral. The Extent Working Group has also submitted a discussion paper proposing include a paper from the Religions working about any of the public agendation are regional response. the reworking and addition of elements to describe extent (including for example extent, duration, dimensions, reduction ratios, image resolution). This is a big piece of work which ORDAC will be digesting and discussing over the next couple of months. In other RSC news, a new Archives Working Group is being established, and the RSC and the RDA Board are jointly setting up a Working Group on Artificial Intelligence. The next RSC meeting will be an in-person meeting in November (venue to be confirmed).
